Where the combined value of all Residential Properties within a continuous Structure or on a Site exceeds £20,000,000 the total amount payable in respect of all claims in relation to the Residential Properties, the Site and the continuous Structure shall not exceed £20,000,000.

SECTION 4 - CONTAMINATED LAND

SECTION 5 - NON-COMPLIANCE WITH BUILDING REGULATIONS

INDEXATION
